I AM AWARE THAT WHILE PARTICIPATING IN THIS EVENT, I MAY COME INTO CONTACT WITH OTHER INDIVIDUALS WHICH MAY INCREASE THE OPPORTUNITY TO COME INTO CONTACT WITH COVID-19 OR OTHER COMMUNICABLE DISEASE.
